MICROSOFT HALOWC FFA QUALIFIER (SPECIAL EVENTS) SWEEPSTAKES OFFICIAL RULES

1. SPONSOR

These Official Rules ("Rules") govern the operation of the Microsoft HaloWC FFA Qualifier (Special Events) Sweepstakes ("Sweepstakes"). Microsoft Corporation, One Microsoft Way, Redmond, WA, 98052, USA, is the Sweepstakes sponsor ("Sponsor").

2. **DEFINITIONS**

4. ELIGIBILITY

To enter, you must be a legal resident of any Xbox Console supported country or region (http://www.xbox.com/en-US/regions), and be sixteen (16) years of age or older. If you are sixteen (16) years of age or older but have not reached the age of majority in your legal place of residence, then you must have consent of a parent/legal guardian.

For doing this you will receive one (1) Sweepstakes Entry. The entry limit is one (1) per person overall. Any attempt by you to obtain more than the stated number of entries by using multiple/different

accounts, email addresses, identities, registrations, logins, or any other methods will void your entries and you may be disqualified. Use of any automated system to participate is prohibited.

We are not responsible for excess, lost, late, or incomplete entries.
